  - iii. guide decision making, including the possibility that a guide may misjudge terrain, weather, trail or river route location, water levels and conditions, and ice conditions.



- 5) I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the directors, officers, owners, agents, and/or employees of Tikippugut Inc.
- 6) The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which Tikippugut Inc. or its agents is a party shall be Nunavut Territory. This agreement shall be construed in accordance with the Laws of Nunavut.
